Organisational Structure

Control of the Organisation is by a <u>Board of Management</u> (described in our Constitution as a Committee) A new committee is elected annually by the Annual General Meeting of the Association, pursuant to Rule 14 of the Constitution

There is no limitation on re-election of former Board Members, but in order to effectively represent the whole Christian community in our broadcast area, no more than two members of the same church, or three members of the same denomination, may be Board members at the same time.

The Office Bearers of the Committee, are elected by the Annual General Meeting, at the time of the election of the Board of Management for the next twelve months. Office Bearers are: (13.1.a) Chairman (13.1.b) Deputy Chairman (13.1.c) Treasurer and (13.1.d) Secretary

The Board of Management consists of the Office Bearers, and <u>four (4) ordinary members</u>. These are elected at the AGM, but the Committee (Board) may appoint a member of the Association to a casual vacancy (13.4) on the Committee, until the time of the next AGM.

Other Appointments to positions of control within the Organisation

There are two other important positions, within the organization, which are filled by office bearers appointed by the Board of Management, rather than by annual election at the AGM.

The <u>Station Manager</u>, and the <u>Technical Adviser</u> are appointed by and accountable to the Board. We are fortunate to have members in these positions, who have been involved with the Organisation from the very beginning, and who have worked tirelessly, in a voluntary capacity, to establish and to maintain our broadcasting facilities and equipment, and to organise Community outreach activities.

Sub-Committees. There are two main Sub-Committees, involved in the day to day management of the Organisation. The Programming Sub-Committee comprises the Station Manager and two Board members, who are also long serving announcers, in consultation with other announcers as required. The Special Events Sub-Committee comprises the Station Manager, Chairman, Treasurer and Board Secretary, and they meet, or consult by telephone, to arrange the live music concerts and other outreach activities which are sponsored by Manning Great Lakes Christian Broadcasters Inc.
